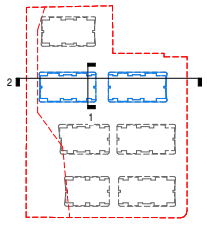




1 BUILDING B - SECTION AA

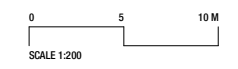
